C. ACTION ON MINUTES OF PREVIOUS MEETING

The 15 January 2009 Board minutes were made available to members prior to meeting. No additions or corrections were noted.

## F. PROJECT PRESENTATIONS

1. LTC Buntin, TNARNG (615-313-2609) presented twenty TN Army National Guard projects for validation, identifying each project and location.
2. LtCol Messer, TNANG-Knoxville (865-895-4213) represented the McGhee Tyson 134<sup>th</sup> ANG Base. He presented six projects for validation and additionally noted that the base is in the process of updating their Installation Development Plan which may result in amendment to projects.
3. Maj Hawkins, TNANG-Memphis (901-291-7479), reviewed one project for the Memphis IAP, 164<sup>th</sup> ANG Base. This project, Base Civil Engineer Maintenance and Training Facilities already has FY10 Congressional Add approval with award by August 2010; therefore, project is dropped from list.
4. LtCol Bradford, TNANG-Nashville, 118<sup>th</sup> ANG Base (615-399-5887), presented two renovation projects current on list. First project is to establish a C-130 Formal Training Unit in an existing hangar and renovation of a Squadron Ops facility into an Intelligence Squadron facility. He also notes that the base is doing a new Installation Development Plan and additional projects will come from it when finished later this year. Both projects are recommended as unilateral due to nature of projects.
5. Mr. John Ellis, USMCR (504-678-1803), informed board of one project for 2013 at Millington for the Memphis Reserve Training Center & VMS on the Millington Naval facility. When questioned by LTC Buntin about possible joint construction for this project, Mr. Ellis expressed that USMCR is not interested pursuing joint at this time.
6. Ms Ladd, USNR (847-688-3767 x 200) stated no projects proposed for Tennessee.
7. USAR did not participate in board.

After presentations, LTC Buntin requested members' interest in potential joint construction. He concluded that the inadequate armory at Memphis may be the only project on list within an area of another co-located component. No other feasible joint-construction projects were identified by members. Therefore, all projects presented are recommended for unilateral construction.

## G. OTHER BUSINESS

The USMCR is to serve as Chair in rotation for the 2011 meeting. Location will be determined.


