

GENERAL PROVISIONS  
JOINT USE (HOST/TENANT)  
MEMORANDUM OF AGREEMENT (MOA)

[City, State]

This agreement is entered into between the United States of America (Host – hereinafter called the USAR) and the Tenant(s) hereinafter called the [ ] ARNG and/or USMCR and/or other Component] for use of the Armed Forces Reserve Center facilities at [address, city, state postal code,] by the USAR and the [ ] ARNG and/or USMCR and/or other Component. The purpose of this Agreement is to delineate rights, duties, and responsibilities as they relate to use, operations, and division of all operational costs for the AFRC.

ARTICLE I – Building and Grounds Management:

A member of the USAR, will be the post Commander, and is hereby empowered to represent the RSC Commander, as related to operation, repair, maintenance, general condition, security, and usage of the entire property, including all facilities thereon. The Post Commander will be the Chairman of the

AFRC Post Council (see Article III). The [ ] ARNG will be represented by the Senior ARNG Commander assigned to the [AFRC or Joint Maintenance Facility (JMF) or other] or as circumstances may dictate. [The USMCR will be represented by the Support Installation and/or the Senior USMCR Commander assigned to delineate rights, duties, and responsibilities as they relate to use, operations, and division of all operational costs for the AFRC.] [Indicate any other Components and who will represent them.]

All facilities sustainment/restoration will be accomplished and paid by the Host USAR. Each Reserve Component will pay for its fair share of Facility Base Operations Support (BOS) and all their exclusive non-facility operational expenses which may include but not be limited to communications, office equipment operations and maintenance, any environmental requirements not related to the real property, special security, and other equipment operations and maintenance.

ARTICLE II – Use of Common and Exclusive Use Areas:

a. Inside Areas: The USAR shall have the sole, exclusive use and possession of that part of the facility so designated on Exhibit A, attached, and made a part of this agreement. The [ ] ARNG shall have the sole, exclusive use

and possession of that part of the facility so designated as such in Exhibit A. [The USMCR shall have the sole, exclusive use and possession of that part of the facility so designated as such in Exhibit A.] [Indicate any other Components and designate on Exhibit A, if applicable.] Utilization of common use areas as designated on Exhibit A shall be on an equitable basis as agreed and scheduled under the provisions of Article III and IV of this agreement.

b. Outside Areas: The USAR shall have the sole, exclusive use and possession of the outside areas so designated on Exhibit B, attached, and made a part of this agreement. The [ ] ARNG shall have the sole, exclusive use and possession of that part of the outside areas so designated in Exhibit B. [The USMCR shall have the sole, exclusive use and possession of that part of the outside areas so designated as such in Exhibit B, and any other Component shall also be designated if applicable.]

Use of the common outside area as designated on Exhibit B shall be on an equitable basis as set forth under the provisions of Article III and IV.

### ARTICLE III – AFRC Post Council:

It is further understood that an AFRC Post Council with equitable representation from each assigned unit/activity shall be established for the purpose
