


SUBJECT: JOINT SERVICE RESERVE COMPONENT FACILITY BOARD-NEW JERSEY

1. **CONVENING THE BOARD:** In accordance with DoD directive 1225.7 dated June 6, 2001 and 1228.8 dated 8 September 2001, the JSRCFB-NJ was called to order at 0830 on 1 June 2011 at the New Jersey Department of Military and Veterans Affairs, Lawrenceville, New Jersey.

3. **ACTION ON MINUTES OF PREVIOUS MEETING:** The Board reviewed the minutes of the previous meeting dated 23 June 2010. Review of Board membership was accomplished and appropriate changes made. A copy of the revised document is attached.

7. **PROJECT RECOMMENDATIONS:**
  - 7.1 All projects listed on the attached project list were discussed. Where unilateral construction is recommended, the reasons are listed in the remarks section.
  - 7.2 All projects recommended for consideration for joint construction are identified on the attached projects list. Information in the remarks column identifies the components that potentially can be partnered for joint construction/renovation projects. The following items are noted with regard to the recommendations:
    - 7.3 The Marine Corp is working with the Army Reserve on possibly making the Picatinny Arsenal project joint. However, it is presently unilateral.
    - 7.4 The USMC stated that basing actions/MILCON Planning at U.S. Army sites (Document AR 5-10) and U.S. Air Force sites (Document AFI 10-503) require a long lead time for implementation.

8. **NEXT MEETING:** The next meeting will be conducted during the third quarter of FY12. The exact date and location for that meeting will be coordinated via e-mail. The New Jersey Army National Guard will serve as the chair for that meeting.

9. **ADJOURNMENT:** With all business concluded, the meeting adjourned at 1000.


