F. PROJECT RECOMMENDATIONS

All of the below listed projects were presented by each service and reviewed by the board to ensure they met the criteria of DoD Directive 1225.7. There were no facilities identified through base closure or force structure reduction that would fulfill any of the requirements presented.

## **1. Mississippi Army National Guard.**

a. PN 280153. MATES Addition/Alteration, Camp Shelby. The existing facility is severely short of authorized work space and work bays based on equipment density. Programmed for 2015

b. PN280389. Operational Readiness Training Complex (ORTC) (BN) Phase 1 of 12. Project is programmed for 2010 at Camp Shelby to support troop density requirements

c. PN280360. Strategic Airfield. An airfield to support strategic operations that require loaded aircraft up to C-17, departure from Camp Shelby. Programmed for 2011.

d. PN280335 Troop Housing, Phase 3 of 12, Camp Shelby. This project is programmed for 2012. The project is a joint project in that it will be utilized by all services training at Camp Shelby. The project will be funded 100% by the MSARNG.

e. PN 280329. CAA/Wetlands Crossings Phase II. Wetland Crossings in Training Areas at Camp Shelby programmed for 2011 and is considered a joint use facility.

f. PN 280307. Wetlands Crossings Phase III. Wetland Crossings in Training Areas at Camp Shelby programmed for 2011 and is considered a joint use facility.

g. PN 28386. Rail Container Facility at Camp Shelby. Project is programmed for 2012 at Camp Shelby to support logistical shipping requirements.

h. PN 280387. Deployment Unit Processing Facility. Project is programmed for 2016 at Camp Shelby to support Deploying Units.

i. PN 280328. Unmanned Aircraft System (UAS) Facility. Project is programmed for 2012 at Camp Shelby to support new unit requirements.

j. PN280389. Operational Readiness Training Complex (ORTC) (BN) Phase 1 (Army). Project is programmed for 2012 at Camp Shelby.

k. PN 280230. Joint Simulation Center Phase I, Camp Shelby, MS. This project is programmed for 2015. This is a joint use facility that will be utilized by all services training at Camp Shelby. The project will be funded 100% by the MSARNG.

l. PN280315. ORTC (BN) 1 of 12 Phase I. Camp Shelby, MS Joint Training Facility Programmed for 2013.

m. PN280407. Battle Command Training Center. Camp Shelby Programmed for 2016.

n. PN280349. RTI Expansion at Camp Shelby programmed for 2017.

o. PN280351. Auto Multi-Purpose Machine Gun Range at Camp Shelby programmed for 2017.

p. PN280405. Decommission Waste Water Treatment Plant (Demolition) at Camp Shelby programmed for 2016.

- q. PN28414. Training Support Brigade (TSB) Complex at Camp Shelby programmed for 216.
- r. PN280418. Training Support Brigade (TSB) Maintenance Facility at Camp Shelby programmed for 2017.
- s. PN280419. Training Support Brigade (TSB) Resident Battalion Facility at Camp Shelby programmed for 2017.
- t. PN280234. Industrial Warehouse at Camp Shelby programmed for 2017.
- u. PN280347. ORTC (BN) Phase 1 at Camp McCain. Training requirements continue to increase at Camp McCain and facilities for this purpose are severely short. Programmed for 2017.
- v. PN280348. ORTC (BN) Phase 2 at Camp McCain. Training requirements continue to increase at Camp McCain and facilities for this purpose are severely short. Programmed for 2019.
- w. PN28280346. SIMNET Facility Expansion at Camp McCain programmed for 2017.
- x. PN280351. Auto Multi-Purpose Machine Gun Range at Camp McCain programmed for 2017.
- y. PN280381. Field Maintenance Shop (FMS 9), Jackson, MS. A new FMS to be constructed in Jackson, MS. OMS shops 4 and 19 were combined and due to a later increase in equipment density and lack of property to expand the existing shop, a new shop is required.
- z. PN 280275. Readiness Center, Clarksdale, MS. This project is programmed for 2014. There is a USAR unit in Clarksdale; however, there are no known plans or requirements that should be considered for joint construction.
- ab. PN 280321. Readiness Center, Southaven, MS. This project is programmed for 2016. The closest Reserve Component unit to this location is a USAR unit in Clarksdale, MS. As stated in a. above, they have no plans for any new construction in that location.
- ab. PN 280327. AVCRAD Addition. This is a large addition to this facility programmed for 2011. This is an Aviation Repair Depot and is considered a joint facility.
- ac. PN 280334. New Readiness Center Jackson, MS (JFH). This project is programmed for 2015 and is necessary due to the shortage of space at the existing facility. Not enough real estate available for joint construction with another component.
- ad. PN 280324. Additions and Alterations to the Readiness Center, Tupelo, MS. This project is programmed for 2015. These additions and alterations are required due to a force structure change in the aviation unit stationed there. There are large changes in unit personnel, ground transportation, and aircraft. There are no other reserve component construction plans in that vicinity any time in the near future.
- ae. PN280283. New Readiness Center Laurel, MS. This project is programmed for 2016 and is necessary due to age and available space in the existing facility.

af. PN280240. New Readiness Center Carthage, MS. This project is programmed for 2016 and is necessary due to age and available space in the existing facility.

ag. PN280382. New Readiness Center Tylertown, MS. This project is programmed for 2017 and is necessary due to age and available space in the existing facility.

ah. PN 280272. Readiness Center, Pascagoula, MS. This project is programmed for 2017. There is a USAR unit in Pascagoula, MS; however, there are no known plans or requirements for new construction in the near future.

ai. PN 280316. AASF/RC Aviation Complex, Jackson, MS. Project is programmed for 2017 due to shortage of authorized space and aging facilities.

aj. PN280380. Access Control Point. Construct a new access control entrance/exit at the Joint Force Headquarters in Jackson, MS.

ak. PN280415. Joint Force Headquarters Office Addition in Jackson, MS programmed for 2011.

al. PN280406. 177<sup>th</sup> Brigade Headquarters. Construct a new Training Support Brigade Headquarters at Camp Shelby Joint Forces Training Center programmed for 2018.

am. PN280408. Auto Multipurpose Machinegun Range. Construct a new Auto Multipurpose Machinegun Range at Camp Shelby Joint Forces Training Center programmed for 2017.

an. PN280409. Grenade Launcher Range. Construct a new Grenade Launcher Range at Camp Shelby Joint Forces Training Center programmed for 2017.

ao. PN280410. Hand Grenade Familiarization Range. Construct a new Hand Grenade Familiarization Range at Camp Shelby Joint Forces Training Center.

ap. PN280411. Heavy Sniper Rifle Range. Construct a new Heavy Sniper Rifle Range at Camp Shelby Joint Forces Training Center programmed for 2017.

aq. PN280412. Combat Pistol Qualification Course. Construct a new Combat Pistol Qualification Course at Camp Shelby Joint Forces Training Center.

ar. PN280413. 10-25 Meter Range. Construct a new 10-25 Meter Range at Camp Shelby Joint Forces Training Center.

as. PN280422. New Readiness Center Jackson. Construct a new Readiness Center in Jackson, MS for the Special Forces.

at. PN280423. Elevated Water Tank. Construct a new Elevated Water Tank at Camp Shelby Joint Forces Training Center programmed for 2011.

au. PN280424. AVCRAD Phase II. Construct AVCRAD Phase II addition at Gulfport, MS.

av. PN280425. AVCRAD Phase III. Construct AVCRAD Phase III addition at Gulfport, MS.

aw. PN280426. Training Aid Support Center (TASC). Construct a Training Aid Support Center at Camp Shelby Joint Force Training Center programmed for 2017.

ax. PN28110036. Sanitary Sewer System Replacement. Replace the Sanitary Sewer System at Camp Shelby Joint Force Training Center programmed for 2012.

ay. PN281101. New Readiness Center Pascagoula, MS Phase II. Construct Phase II for the new Readiness Center in Pascagoula, MS programmed for 2020.

## **2. United States Air Force Reserve.**

PNMAHG079000. Corrosion Control/C-130 Wash Facility. This facility is necessary for continued operations. Programmed for 2013

## **3. Mississippi Air National Guard**

a. PN LRXQ989041. Construct Security Forces Facility (Jackson). A facility is required to provide adequate space for operations and training, vehicle and personnel ID, armory space, and space for the Combat Arms Training Simulator (CATS).

b. PN JTVE099057. Base Entrance Relocation (Gulfport). The existing entrance violates DOD Force Protection Standards to adequately meet the standoff requirements. The existing gate is located too close to the Troop Quarters Facility.

c. PN LRXQ059039. Construct Crash Rescue Facility (Jackson). This project is programmed for 2011. The project includes the demolition of the existing fire station (12,100 SF) and construction of a new Facility (20,100 SF). Existing fire station is severely under scope and suffers from structural problems due to soil conditions.

d. PN LRXQxxxx. Expeditionary Forces Center. (Jackson). This project is programmed for 2016. The project includes the construction of a composite mobility processing center (34,200 SF), and medical training facility (20,000 SF). The project also includes modifications to the existing clinic to meet user needs. The facility will actually be a joint use facility, but funded 100% by the MSANG.

e. PN MDVL069177. Bed Down Facility Phase I (Meridian). This Base will be aligned with the 18<sup>th</sup> Air Force and has a new base mission that requires properly sized adequately configured facility to support a Component Numbered Air Force Operations Center.

## **4. United States Navy Reserve.**

a. PN OM013. Army Reserve Center, Meridian, MS. This is a new facility programmed for 2016 that could be constructed as a joint facility should there be an opportunity there with the Army National Guard; however, none could be identified.

b. PN CAR 10-MS012 . Army Reserve Center, Lyon, MS. This is a new facility is unprogrammed.

c. PN 12111 . Army Reserve Center, Starkville, MS. This is a new facility programmed for 2016.

d. PN CAR 10-MS018 . Army Reserve Center, Tupelo, MS. This is a new facility is unprogrammed.
