A. CONVENING THE BOARD

- E. PROJECT LISTING. All projects considered by the board are found at Enclosure 1.
- F. PROJECT RECOMMENDATIONS. Projects reviewed are listed below by service, with JSRCFB comments.

DC Air National Guard

1. Munitions Load Crew Training Facility (PN #AJXF039040): \$3.00M. Construct a new facility at Joint Base Andrews for munitions crew training and corrosion control actions on F-16 aircraft. Programmed for FY15.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
2. Mobility Processing Facility (PN #AJXF42039): \$1.75M. Construct a new administrative facility at Joint Base Andrews to support deployment actions. Programmed for FY17.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
3. F-16 Maintenance Complex Add/Alt (PN #AJXF129020): \$11.0M. Renovate existing F-16 maintenance structures. Programmed for FY16.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.

U.S. Marine Corps Reserve

1. Project Name (PN #P002): \$15.50M. Construct a new vehicle maintenance facility co-located with future RTC (or NGRC). Not yet programmed.  
Could be done in conjunction with a joint project such as the prospective Joint MDARNG-USMCR Baltimore County Northeast NGRC.
2. Project Name (240162): \$ Unknown. Construct a new joint National Guard/Reserve Center (NGRC) for units located at the Baltimore USMC RTC. Not yet programmed.  
MDARNG and USMCR continue to be interested in a joint NGRC facility in northeastern Baltimore County to be constructed sometime around FY23-FY25. The actual programming year will remain flexible at this point. The services have continued bilateral discussions on this project and have agreed to share unit requirements information in FY13 to drive the MDARNG search for a suitable 20+ acre parcel, and development of conceptual joint programming documents. The services agree that MDARNG will seek acquisition of a suitable parcel through a real property exchange with Baltimore County under provisions of MD Code of Public Safety 13-217, trading existing but unsuitable current properties for a buildable parcel that meets the needs of both services. MDARNG will take the lead in developing a draft joint economic analysis and draft DD Forms 1390/1391; USMCR will provide joint MOA examples and take the lead in providing a draft joint MOA covering inter-service support agreements. JSRCFB recommends joint construction.

U.S. Navy Reserve

1. No projects programmed or planned in Maryland within the current JSRCFB planning window.

U.S. Army Reserve

1. Project Name (PN # CAR12-12129/CAR 13-67705): \$21.00M. Construct a 500-member Army Reserve Center (ARC) on post at Aberdeen Proving Ground (APG), MD. Includes Land, training building, Organizational Maintenance Shop (OMS), and unheated storage building. Replaces 2 obsolete facilities at APG and 1 in Abingdon, MD. Programmed for FY13.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
2. Project Name (PN # 19985/CAR 13-68077): \$16.5M. Nearing completion of 46,000 SF Add/Alt to existing facility on 27-acre site at Curtis Bay.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
3. Project Name (PN # CAR12-10961 / CAR 14-67663): \$16.5M. Construct a new 600-soldier Army Reserve Center (ARC) in Riverdale, MD, to replace Annapolis ARC (12,956 SF), Riverdale USARC (30,603 SF) and Upper Marlboro ARC (31,689 SF). Programmed for FY14.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
4. Project Name (PN # CAR 18-77135): \$20.7M. Construct a new US Army Reserve Center (USARC) in Gaithersburg, MD. Projected for FY20.  
Not suited for other services' units/locations. JSRCFB recommends continue with programmed unilateral construction.
5. Project Name (Cumberland FFR): \$11.10M. Recapitalize US Army Reserve Center (USARC) in Allegany County, MD. Projected for sometime after FY20.  
Conceptual project only. Would renovate Soldiers Memorial USARC in Cumberland. Current facility is on 6 acres. MDARNG discussed a potential replacement for the MDARNG Cumberland RC in the FY20+ time horizon. USAR and MDARNG could look into potential for a joint project, involving MDARNG land acquisition through real property exchange. The services agreed to continue discussing this as a potential joint project on the long-term time horizon. JSRCFB recommend joint construction.
6. Army Reserve has a potential interest in a new facility in the Baltimore metro area to replace the Sheridan USARC in Baltimore, MD. Representatives indicated continued interest in a potential joint project with the MDARNG in Howard County.  
MDARNG indicated that the project has been moved off current FYDP but will likely be re-added in FY19. MDARNG and USAR agree to continue discussing a joint project. JSRCFB recommend joint construction.

U.S. Air Force Reserve

1. Air Force Reserve did not attend the FY13 JSRCFB. Consequently, no projects were submitted or considered in this year's board.

Maryland Army National Guard

1. Gunpowder Military Reservation Range Renovation (PN #240194): \$3.38M. Renovate existing ranges at Gunpowder MR in Baltimore County. Programmed for FY13.  
This UMMC project includes state and federal funding. It will produce a fully baffled combat pistol range and an open air rifle range for use with Short-range Training Ammunition (SRTA) rounds only. Not suited for other services' units/locations. Continue with programmed unilateral construction. JSRCFB recommends unilateral construction.
2. Easton Readiness Center (PN #240173): \$14.8M. Construct a new 41,000+ SF Readiness Center to replace the Readiness Center in Easton, MD. Programmed for FY15.  
MDARNG will construct a replacement to support two small units and a state Veterans' honor Guard team. Current discussions include the possibility of an innovative joint project with Talbot County which will expand the county community center and provide a facility with shared use and shared costs. JSRCFB recommends unilateral construction.
3. Havre de Grace Readiness Center (PN #240165): \$16.0M. Construct a new 61,325 SF multi-unit Readiness Center to replace the Readiness Center at the State Military Reservation in Havre de Grace, MD. Programmed for FY15.  
Not suited for other services' units/locations. JSRCFB recommends unilateral construction.
4. Howard County National Guard Reserve Center (PN # 240149): \$20.175M. Construct a new 65,000+ SF multi-unit joint National Guard/Reserve Center in Howard County on a new 20+ acre parcel. Replaces two Readiness Centers (Ellicott City and Catonsville). Was programmed for FY17, now moved into the out years.  
MDARNG and USAR have held discussions and prepared draft joint programming documents. USAR continues to be interested in the project in FY19 or later. JSRCFB recommends joint construction.
5. Combined Support Maintenance Shop (CSMS) Phase I (PN # 240147): \$16.0M. Construct a new 50,000 SF sustainment-level maintenance facility to replace the existing CSMS facilities at the State Military Reservation in Havre de Grace, MD. TAG-MD #1 priority.  
MDARNG has re-worked this project into a phased project as a reflection of new prioritization criteria which factors in total project cost. MDARNG plans a phase II facility focused on the automotive components of the sustainment maintenance mission. Not suited for other services' units/locations. JSRCFB recommends unilateral construction.

Maryland Army National Guard

6. White Oak Readiness Center (PN # 240148): \$18.3M. Construct a new 60,000 SF multi-unit Readiness Center on the current 14-acre White Oak Readiness Center site. Replace Readiness Centers in White Oak and Greenbelt. TAG-MD #2 priority.  
Not suited for other services' units/locations. JSRCFB recommends unilateral construction.
7. Baltimore County Northeast Joint National Guard/Reserve Center (PN # 240162): \$20.0M. Construct a new 65,000+ SF multi-unit joint NGRC or Readiness Center in Northeastern Baltimore County on a new parcel of 20+ acres. Replace Readiness Center in Parkville and possibly others in Baltimore County. TAG-MD #3 priority.  
Discussed previously in USMCR portion. MDARNG and USMCR continue to be interested in a joint NGRC facility in northeastern Baltimore County to be constructed sometime around FY23-FY25. The services will continue bilateral discussions and staffing for this project. JSRCFB recommends joint construction.

Maryland Air National Guard

1. Composite Training Site (PN #PJMS909928): \$10.30M. Construct a new training facility at Warfield Air National Guard Base in Middle River, MD. Programmed for FY12.  
Project is in construction, nearly complete. Unilateral construction.
2. Cyber/ISR and NWS Facility (PN #PJMS129058): \$12.00M. Construct a new Cyber/ISR Network Warfare Group (NWG) facility to support new missions at Warfield Air National Guard Base in Middle River, MD. Programmed for FY14.  
Not suited for other services' units/locations. JSRCFB recommends unilateral construction.
3. Network Warfare Squadron (NWS) Facility (PN #MMMD12973): \$3.70M. Construct a new NWS facility at Fort Meade, MD. Could be a joint project with active component elements. Programmed for FY14.  
JSRCFB recommends continue with programmed construction and joint with active components if possible.
4. Dining Facility (PN #PJMS929916): \$8.80M. Construct a new dining facility to support elements at Warfield Air National Guard Base in Middle River, MD. Programmed for FY16.  
Not suited for other services' units/locations. JSRCFB recommends unilateral construction.
5. Security Forces HQ Bldg (PN #PJMS029019): \$4.30M. Construct a new headquarters building for Security Forces at Warfield Air National Guard Base in Middle River, MD. Programmed for FY18. Potential for cancellation due to force structure changes (loss of flying units). JSRCFB recommends unilateral construction.

Maryland Air National Guard

6. Munitions Complex (PN #PJMS959522): \$7.50M. Relocate aircraft munitions facility at Warfield Air National Guard Base in Middle River, MD. Projected for FY21. Potential for cancellation due to force structure changes (loss of flying units). JSRCFB recommends unilateral construction.
7. BCE Maintenance Facility (PN #PJMS929715): \$2.30M. Construct a new BCE maintenance facility at Warfield Air National Guard Base in Middle River, MD. Programmed for FY17. Not suited for other services' units/locations. JSRCFB recommends unilateral construction.
8. Corrosion Control Facility (PN #PJMS989025): \$10.40M. Construct a new corrosion control facility at Warfield Air National Guard Base in Middle River, MD. Programmed for FY17. Probably will be down-sized to a renovation. Not suited for other services' units/locations. JSRCFB recommends unilateral construction.

G. OTHER BUSINESS.

1. MDARNG discussed the potential for a multi-service range complex in central Maryland, which could involve active and reserve components. Since all services have an interest in a suitable weapons facility, MDARNG agreed to circulate a white paper to discuss the issue and determine the level of interest in developing a joint range project.

2. MDARNG agrees to chair the FY14 Maryland JSRCFB.

H. NEXT MEETING.

1. The FY14 Maryland JSRCFB will be conducted on Wednesday, 23 April 2014, beginning at 1300.

2. Location will either be at Fifth Regiment Armory in Baltimore or another mutually agreed upon location, and will incorporate an audio bridge and possibly VTC capability.

I. ADJOURNMENT. The FY12 Maryland JSRCFB adjourned at 1402.
