6. Discussion

- CPT Steven Belford, LA ARNG, began the meeting by introducing the Camp Minden project and the top priority for LA ARNG being the Regional Training Institute.
- FY19 and FY 20 LA ARNG projects have just recently been submitted. This will be a readiness center for the 2nd Battalion, 256th Brigade. The property has been secured in Lake Charles. Lake Charles project is being proposed as a joint project with USAR.
- The Navy has involved the Plaquemine's Parish government in the rear gate project due to possible expansion of Barriere Road. The Navy has engaged SDDC for permission to use DoD funds on non-DoD property for relocation of the main gate.
- Possibly relocate 377th TSC out of four buildings and consolidate into one Army Reserve Center. The 3rd Battalion, 23rd Marines are moving out of building 492 at NAS JRB, New Orleans, and the 377th TSC has expressed interest in moving into this facility in lieu of their project.

7. Next Meeting

The next scheduled meeting will be 30 July 2014, at 1000 at the AFRC in Baton Rouge, chaired by USAR. Future meetings will be hosted by the Marine Reserve in 2015, the Army National Guard in 2016, the Air National Guard in 2017, and the Navy Reserve in 2018.




