MEMORANDUM FOR RECORD

SUBJECT: Joint Services Reserve Component Facility (JSRCFB) Board Meeting Minutes

1. In accordance with the DOD Directive 1225.07, dated 23 April 2007, the board held its annual meeting at 0900 hours on 04 March 2014 at the Massachusetts National Guard Joint Force Headquarters Building, 2 Randolph Road, Hanscom AFB, Bedford MA 01731.
2. The following individuals were in attendance either in person or by audio bridge:

3. Meeting began with acceptance of last year's minutes. Mr. Dion-Bernier, USNR, motioned to accept and was seconded by Mr. Connor USMCR. Last year's minutes accepted. Each component briefed their respective projects. The following is an overview of projects reviewed.
 - a. Number of projects reviewed: 29
 - b. Number recommended for joint construction: 0
 - c. Number recommended for unilateral construction: 29
 - d. Number not recommended for construction: 0

4. Project recommendations:

MAARNG: The Massachusetts Army National Guard presented a total of 8 projects for review. All projects recommended for unilateral recertification. The projects consist of 5 renovation/alteration projects at the Quincy, Dorchester, Melrose, West Newton, and Braintree Readiness Centers; 1 new Readiness Center at Camp Edwards, Bourne, MA to support the 181 EN Vertical. Two (2) projects are ranges (MPMG and MRF) for an Army National Guard Training Site; these were certified as unilateral due to the training mission. All training facilities and ranges at the MTA Camp Edwards are available for joint use to support training requirements though construction is certified as unilateral.

USAR: The Army Reserve presented a total of 3 projects; all three were recertified unilateral due to geographic locations and specific mission requirements.

ANG: The Air National Guard presented a total of 15 projects; all were recertified unilateral due to geographic, stationing, and mission constraints. There was discussion for evaluating the Small Arms Indoor Firing Range as a joint project with the USAFR to meet requirements of both branches and evaluation of the Relocating Main Gate Entrance/Exit as a joint project with the MAARNG.

USAFR: The Air Force Reserve presented a total of 3 projects all were recommended for recertification of unilateral construction due to their geographic locations and specific mission requirements. The Air Force Reserve expressed interest in other services that use and benefit from their physical fitness facilities to contribute to the construction of their planned addition. The ANG expressed interest to evaluate the feasibility of this being a joint project.


USMCR: The USMCR presented 0 projects.


