

BOARD MEETING MINUTES

28 FEBRUARY 2013

A. CONVENING THE BOARD

In accordance with the DOD Directive 1225.07, dated 23 April 2007, the board held its annual meeting at 1300 hours on 28 FEBRUARY 2013 at the Massachusetts National Guard Joint Force Headquarters Building, 50 Maple Street, Milford, MA 01757.

B. ATTENDANCE

The following individuals were in attendance either in person or by audio bridge: MAJ Nathan Wilder and Mr. Raymond Cottengaim, MA Army National Guard; Mr. Robert Blair, 102nd IW ANG; CAPT Sean Cahill, 104th FW ANG; Mr. Lee Mortensen, US Army Reserve; Mr. David Kocot, Air Force Reserve; Mr. Murray Seals, US Marine Corps Reserve. Mr. Gary Dion-Bernier of the US Navy Reserve, though not in person, reviewed all projects.

Each component briefed their respective projects. The following is an overview of projects reviewed.

D. PROJECT RECOMMENDATIONS

MAARNG: The Massachusetts Army National Guard presented a total of 11 projects consisting of 5 new projects and 6 projects for unilateral recertification. The new projects consist of 3 alteration projects at the Melrose, West Newton, and Braintree Readiness Centers; 1 new Readiness Center at Camp Edwards, Bourne, MA; and a Multi-Purpose Machine Gun Range at Camp Edwards, Bourne, MA. For reasons of geographic proximity to the needs of other organizations and their requirements 8 projects were certified as unilateral; 2 projects are ranges for an Army National Guard Training Site, these were certified as unilateral due to the training mission; and 1 project is for environmental remediation at the Army National Guard Training Site, this was also certified as unilateral.

All training facilities and ranges at the MTA Camp Edwards are available for joint use to support training requirements though construction is certified as unilateral.

USAR: The Army Reserve presented a total of 3 projects; all three were recertified unilateral due to geographic locations and specific mission requirements.

ANG: The Air National Guard presented a total of 17 projects, 13 were recertified unilateral and 4 projects were certified unilateral due to geographic, stationing, and mission constraints.

The Air National Guard expressed Interest to have the Army National Guard participate in their relocation of the main gate project (AXQD129090). The Army National Guard was not interested due to requirements and funding. Additional interest was expressed by the Air National Guard to have partners in the construction of an indoor range (AXQD 059335). The Air Force Reserve is interested in discussing the feasibility of a joint small arms range with the Air National Guard though the project is certified as unilateral construction.

USAFR: The Air Force Reserve presented a total of 3 projects all were recommended for recertification of unilateral construction due to their geographic locations and specific mission requirements. The Air Force Reserve expressed interest in other services that use and benefit from their physical fitness facilities to contribute to the construction of their planned addition. The ANG expressed interest to evaluate the feasibility of this being a joint project.

USMCR: The USMCR presented 0 projects.

USNR: The USNR presented 0 projects.

E. OTHER BUSINESS

The next JSRCFB meeting will be hosted by MA Army National Guard and is scheduled for 27 February 2014 at 1400 EST. The FY 2013 JSRCFB was adjourned at 1335 hours. All matters brought before the board were discussed thoroughly and all matters were completed prior to adjournment.


