

Meeting Minutes of the

A. Convening the Board:

In accordance with DoD Directive 1225.07 and DoD Instruction 1225.8, the New Mexico Joint Service Reserve Component Facility Board convened at 1000 on 28 May 2014 to review and validate the Military Construction requirements of each Reserve Component that has units in New Mexico and to make recommendations on each proposed MILCON project for either joint or unilateral construction.

C. Action on minutes of previous meeting:

Mr. Douglas Conner of the USMCR motioned that last year's minutes be reapproved, LtCol Couse seconded. The minutes of the previous meeting were re-approved.

E. Project Listing: (See attachment) The Board considered all projects on the attached project list and is validating and recommending all projects for unilateral construction.

No other component had MILCON projects for board consideration.

F. Project Review and Recommendations See Consolidated Project Listing.

1. **Army National Guard:** LTC Giesler briefed the listing of projects and noted changes to the original AASF to Readiness Center. LTC Giesler spoke about the large project cuts that occurred this year on the FYDP, the scrutiny of funding, and offered the opportunity to pair with other components to develop an RTI for all reserve components to use. LTC Green echoed the same budget restrictions occurred on their end. ISR and scoring will become increasingly important, and cost of re-stationing will further impact the picture. LTC Giesler spoke about the IRP process which identifies the scoring for the NMARNG, which allows for a better method to score more criteria fairly amongst other states. More points are offered for a joint project.
2. **U.S. Army Reserve:** LTC Mark Green FY17 Grow the Army is at 100% utilization project number 69582, Las Cruces. No new projects in NM right now. Competition amongst other RC's makes it difficult to get more projects. LTC Couse asked what the training requirement is for each component is. LTC Giesler spoke about small arms, crew served, convoy live fire, and grenade course, additionally we have ongoing discussions with NM Tech to coordinate land use for mortar fire (this is not a military range), but the current location is located on Stallion Range at White Sands Missile Range. LTC Green indicated they are using local training areas difficulties include a high cost to ensure cultural and environmental portions are taken care of prior to use. If it's within driving distance, for units, we will communicate that and ensure MOU/MOA are in place.
3. **U.S. Marine Reserve:** None. Priority number 5 large military equipment parking are and ECS 171 storage. It will hold 8,000 pieces of equipment (Barstow, CA). Any location in the southeastern portion of New Mexico could potentially utilize this facility. This may be a training opportunity to participate in a troop training project.
4. **U.S. Navy Reserve:** None.
5. **U.S. Air Force Reserve:** No units assigned to NM. Large IMA program with Kirtland, but no unit. Lt. Col Couse indicated she would confirm this.
6. **Other Business:** Joint Training Site opportunities; no interest for the Marine Reserve or the Navy Reserve, they are currently located on Kirtland AFB.

The board scheduled the next meeting for 13 May 15 beginning at 1000 Mountain Time. The Navy Reserve will be hosting this meeting, location TBD.
