3. DoDD 1225.08 cancels DD Form 2162, "Joint Service Reserve Component Facilities Board (JSRCFB) Project Analysis."
4. DoDD 1225.08 requires that all RC projects submitted for the President's budget have been reviewed by the SFB for joint potential and that all unilateral projects are justified in accordance with section 18234 of Reference (d).
