SUBJECT: 2017 Colorado State Facilities Board Minutes

1. Authority. In accordance with DoD Instruction (DODI) 1225.08, 10 May 2016 (see Enclosure), the Colorado State Facilities Board (SFB), formerly known as the Joint Service Reserve Component Facility Board (JSRCFB), convened at 0900 (Mountain) on Thursday, 23 February 2017. Participation was via teleconference and in-person participation at the Colorado National Guard Joint Forces Headquarters, Centennial, CO.

2. Membership. Per Enclosure 3 of the DODI, participation consists of a primary and alternate members of “each engineer organization responsible for the RC facilities program within a State....Active Component (AC) engineer representatives from each active duty installation within the State are encouraged to participate to share information on upcoming construction projects and available facilities and land for possible joint or unilateral use, as well as other opportunities for efficiencies, such as partnerships and service contracts.” Historically, the Colorado Army National Guard (COARNG) has chaired this meeting

5. New Business. The Board considered the following future projects for possible joint participation:

a. COARNG. In addition to the projects listed below, The COARNG is also completing an Area Development Plan (ADP) for its enclave on Fort Carson. This project may result in additional joint opportunities.

b. US Army Reserve (USAR). The following projects are under consideration with the Army Reserve Installation Management (ARIM) office. The 88th Regional Support Command is also seeking underutilized space supporting restationing to Colorado of an engineer (sapper) company from Kansas. The COARNG agreed to discuss the topic after the meeting.

c. Buckley AFB (BAFB). No projects were presented for consideration, as all currently under development are pre-decisional. However, BAFB did offer that they are conducting a table-top refresher of their Public-Public-Public Partnership (P4) initiative in May 2017, details to be provided. BAFB is also planning an update to the ADP for the northeast corner of the base, timing to be determined. All current or potential tenants will be includes.

d. Fort Carson. Fort Carson remains open to considering Reserve Component (RC) stationing requests, and incorporating them into their planning efforts. Fort Carson plans six ADPs in FY17 and FY18, which will identify areas for potential development. Although developable space is at a premium, there is no initiative to convert training land into area for development.

e. US Navy Reserve (USNR). No projects were presented for consideration.

f. US Marine Corps Reserve (USMCR). No projects were presented for consideration.

6. Other. The following additional topics were discussed:

a. The COARNG offers to continue acting as the chairperson of the meeting. DODI 1225.08 specifies the membership requirements of the Board, but is silent on assignment of the chairperson. The COARNG has chaired the meeting for at least the last six years, and serves as the primary continuity for the Board.
