C. Review and Approve Minutes of 30 March 2016 Meeting:

Mr. Vogel moved to approve the minutes of the 30 March 2016 Joint Service Reserve Component Facility Board meeting as presented. The motion was seconded by 2d Lt Erpenbach and the motion was approved unanimously.

D. Review of South Dakota 2017 Long Range Construction Plan (LRCP)

The Board reviewed the 2017 Long Range Construction Plan.

Project Summaries:

1. Number of projects reviewed – 30;
2. Number of projects recommended for joint construction – 2;

3. Number of projects recommended for unilateral construction – 28; and,
4. Number not recommended for construction – 0.

2d Lt Erpenbach noted that the ANG Fuel Systems/Corrosion Control Hangar project in Sioux Falls is scheduled to be a 2020 project and the ANG Maintenance Hangar project in Sioux Falls is scheduled to be a 2021 project. COL Petrik indicated that ARNG Project 460158 has been submitted as a 2024 project; however, it has not yet been picked up on the Future Year Defense Plan (FYDP).

Mr. Vogel moved to approve the 2017 Long Range Construction Plan as presented with two projects recommended for possible joint construction and 28 projects recommended for unilateral construction. The motion was seconded by 2d Lt Erpenbach and the motion was approved unanimously.

E. Review of Changes to Training Area and Ranges

The Board reviewed the following conversions of Indoor Firing ranges in accordance with NRG 420-10 (dated 11 July 2003):

1. PN466140 – Convert IFR – Flandreau Armory – Convert existing Indoor Firing Range to Multipurpose Training Area.
2. PN466144 – Convert IFR – DeSmet Armory – Convert existing Indoor Firing Range to Multipurpose Training Area
3. PN466142 – Convert IFR – Duke Corning Armory. Convert Indoor Firing Range to Multipurpose Training Area.
4. PN466143 – Convert IFR – Mitchell Armory – Convert existing Indoor Firing Range to Multipurpose Training Area
5. PN466023 – Convert IFR – Vermillion Armory – Convert existing Indoor Firing Range to Classroom

The Board reviewed the following changes in Training Grounds:

1. Indian Creek – In process of drafting MOA to formalize use of land;
2. Yankton Training Area – State modified the lease boundary resulting in 21.6 acres of training land being available for use; and,
3. Camp Iyatoka (Big Stone Lake) – In process of completing a no cost lease.
