In accordance with DOD Manual 1225.08, dated December 19, 2017, and per last year's board recommended meeting format, the Board held its annual State Facility Board Meeting via teleconference at 10:00 am (EST) on **14 March 2018**. CPT Henry, NHARNG, read the board purpose as written in DoDI 1225.8, "The mission for the State Facility Board (SFB) is to maximize usage of Reserve component land, facilities, and installations by promulgating joint use by two or more components. Additionally, the SFB shall pursue opportunities for shared use with any active components in their area."
