E. MISCELLANEOUS COMMENTARY OF PROJECTS:

1. At 1000 hrs EST, 12 Aug 14, Board Chair, Mr. Michael F. Lohan, Community Planner US Army Reserve (USAR) convened the Interim FY 2014 Joint Service Reserve Component Facility Board (JSRCFB) meeting by teleconference.

2. The board reviewed all projects listed on the Virginia JSRCFB project list. Comments made by the board on the projects submitted and on changes are stated in the minutes, and the 2014 list is submitted as enclosure one.

3. The 2014 Project Spreadsheets were reviewed by the board for possible joint construction; comments are as follows:

- a. DC Army National Guard (DCARNG) representation was not present at this meeting due to down phone lines. - d.
