

# **2017 BOARD MEETING MINUTES OF THE STATE FACILITY BOARD (SFB) NEW HAMPSHIRE**

## **A. CONVENING THE SFB**

In accordance with DOD Directive 1225.07, dated 6 June 2001, Certified Current as of April 23, 2007 and per last year's board recommended meeting format, the Board held its annual State Facility Board Meeting via Defense Collaboration Services (DCS), at 10:00 am (EST) on **15 March 2017**. CPT Henry, NHARNG, read the board purpose as written in DoDI 1225.8, "The mission for the State Facility Board (SFB) is to maximize usage of Reserve component land, facilities, and installations by promulgating joint use by two or more components. Additionally, the SFB shall pursue opportunities for shared use with any Active components in their area."

In accordance with DOD Instructions 1225.8, the Board convened with representatives from the Marine Corps Reserves, Air National Guard, Army Reserve, and Army National Guard residing in New Hampshire. - c. COL Mikolaities briefly discussed the construction of the baffled ranges at Center Strafford, stating all who wanted to use them were welcome. Lt. Col. Mozzoni joined the conversation stating the Air National Guard was not interested in the ranges at Center Strafford however would be interested in joint construction of an indoor range at Pease Air Guard base.


All business was concluded and CPT Henry called for the completion of all matters before adjourning the Board meeting.
