F. PROJECT RECOMMENDATION

All of the below listed projects were presented by each service and reviewed by the board to ensure they met the criteria of DoD Instruction 1225.08. There were no facilities identified through base closure or force structure reduction that would fulfill any of the requirements presented.

1. **Mississippi Army National Guard**

- a. See attachment #2

2. **United States Air Force Reserve**

- a. Aeromedical Staging Squadron Facility, Keesler AFB, MS. PA changed to \$4.55M and projected in FY19
- b. Reserve Forces Aeromedical Evacuation Training Facility; not on FYDP. Possible future project for Joint with MSANG.

3. **Mississippi Air National Guard**

- a. Construct Crash Rescue Facility (Jackson). This project is programmed for 2021. The project includes demolition of the existing fire station (12,100 SF) and construction of a new facility (20,100 SF). Existing fire station is severely under scope and suffers from structural problems due to soil conditions. PA updated to \$9.3M
- b. Construct ADAL CNAF Facility (Bldg 104) (Meridian). This facility is not programmed at this time.
- c. ADAL Aircraft Maintenance Shops (Bldg 150) (Meridian) This facility is not currently programmed.
- d. Repair 255 ACS Comm Electronics Facility (Gulfport). This project will provide 255 ACS with a properly configured shop, training and office space, as well as space to support the CRTIC personnel and entire squadron.

4. **United States Navy Reserve**

No projects presented.

5. **United States Army Reserve**

- a. Army Reserve Center, Meridian, MS. This facility is not programmed. This project is considered for possible joint construction.
- b. Army Reserve Center, Jackson, MS. This is a new facility and is not programmed at this time. This project is considered for possible joint construction.
- c. Camp Shelby. Joint restoration project for Building #6505 to support USAR Equipment Concentration Site.

6. **United State Marine Corp Reserve**

No projects presented.

G. OTHER BUSINESS

1. Mr. Robert Bayler asked if any O&M projects could be utilized as joint; no RCs indicated available projects.
2. Mr. Robert Bayler asked if energy, maintenance services, contract services, partnerships, etc could be utilized as joint; no RCs indicated available projects.
3. Mr. Robert Bayler asked if any vacant or underutilized facilities could be utilized as joint; no RCs indicated available projects; however, the USAR indicated there was an area utilized by USMCR in the past that was available in the Jackson area.

4. Available land/Real Property Actions: No RCs indicated available projects/land.
5. Initiatives for readiness and efficiencies: Thompson Field / USPFO / CST Compound was suggested to be security enhanced via a new fence line. Currently most of these areas area exposed. A project in this area would enhance readiness/safety for assigned personnel.
