F. Project recommendations.

The board is looking for opportunities for joint development and joint use of facilities in Alaska.

Army National Guard C CO (LRS)/1-297th R&S may be able to coordinate with the Marine Corps Reserve RECON unit for joint use of the Marine Corps Reserve/Consolidation Facility, specifically for parachute rigging. Also, as Marine RECON and C CO (LRS)/1-297th R&S mission overlay significantly there is a possibility of joint training opportunities. Additionally the recommendation was made to coordinate with ANG Para-Rescue Squadron, Commander Tom Stevens. There is potential to work with the Parachute Rigging unit for joint facilities use with Air National Guard.

There may be potential for joint use of the proposed Army National Guard Multipurpose Facility by the Navy Reserves forces stationed on JBER. This facility would be used for; and engagement skills trainer (EST), call for fire trainer, etc. Further discussion is necessary as the project matures.

After the meeting additional discussions were had between the Navy Reserves and AKARNG on the possibility of Joint Use or Joint Construction of one or both of the proposed Multi Purpose Training

Facility and Troop Medical Clinic on Camp Carroll, JBER. Currently these projects are projected for construction by the AKARNG in after FY 18. The Navy Reserve would be willing to discuss the possibility of a joint project for these facilities if they were to be programmed for construction within the next 7 years. As both of these facilities represent an immediate need to both the AKARNG and the Navy Reserve more discussions will take place to explore the possibility of developing a joint project.

Navy sees possible opportunity for joint usage with the Army National Guard Troop Medical Clinic on Camp Carroll, Fort Richardson.

The Air National Guard sees potential for joint training opportunities with the Navy Civil Engineering Unit Stationed on JBER. Point of Contact is LT(SG) Paul Davis, at (907)384-687.
