1. Mr. Meynier, USMCR - reported that the USMCR has no proposed construction projects for West Virginia.

2. Lt Col Thomas, 130th AW, WVANG - No new projects. #1 project is a Force Protection Project for Coonskin Drive, Charleston, WV received funding started that project in June 2016. Next project is the Communication Facility scheduled for 2020. Lt Col John R. Poland, 167th AW, WVANG – added Indoor shooting Range as Martinsburg priority two project for 2020. Removed two projects from the JSB list one with the USAR and one with the ARNG.

3. Mr. Stevenson, 99th RSC, USAR – Has 6 projects in WV change project date for Wheeling to 2025. Remove line item #2 Martinsburg and #3 Parkersburg. Make Clarksburg #2 change date 2026+. Make Bluefield #3 change date to 2026+. Make Dunbar #4 change date to 2026+. JFHQ Charleston with ARNG #5

and Martinsburg #6 to be Study Joint Auth w/ARNG. The USAR wishes to be considered as Study Joint Auth w/ARNG on all six projects.

4. Mr. Larry Becher (WVARNG) - reviewed current project list from the WVARNG. No new projects with 32 projects planned. The Buckhannon Brushy Fork, Readiness Center has been selected for the 2020 FYDP. Parkersburg Readiness Center is now our #1 it is joint venture with WVU-P University but will be Unilateral Auth/P&D with the services. AFRC Martinsburg is still in the early stages of planning and is open for joint use with other services and will now be our #2. The USPFO and FMS shop at Buckhannon have moved down to #4 and #5 with Charleston JFHQ moving to #3, all are open for joint consideration. The remaining items on the list are for our Readiness Center Transformation Master Plan (RCTMP) a national ARNG Master Plan sent to Congress to ask for additional funds to upgrade our aging Readiness Centers across the nation. All open for possible Joint considerations.

6. Motion was made by the USMCR to approve the project list as changed/updated. Second, by the USAR. Vote was taken and the motion was carried to approve the listing.


