4. Identify additional joint opportunities to leverage efficiencies across the RC facilities programs
5. Identify vacant or underutilized facilities for possible reuse
6. Identify available land for potential real property actions with other RC's
7. Share initiatives across RC's within their respective State to improve facility efficiencies and readiness across all components
8. Make recommendations to the SESG or DASD(RP&R) on any facility needs of the RC's of that State that have potential to enhance readiness or to provide a significant return on investment
9. Respond to inquiries from the SESG and DASD(RP&R)
10. Address any other RC installations matters of interest to the membership or the SESG
