C. ACTION ON MINUTES OF PREVIOUS MEETING

D. PROJECT RECOMMENDATIONS

Mr. Souchet, US Marine Corps Reserve, had no projects to report in Kentucky.

Mr. Lachicotte, US Army Reserve, announced one project on Fort Knox KY. The USAR project number 12571 is programmed for a 20 million dollars Army Aviation Support Facility, located at Fort Knox Kentucky. This project was recommended as unilateral.

Lt Col Howard, KY Air National Guard, announced four projects two on the Air National Guard Base in Louisville, KY.

1. Louisville Grade Lane Bypass Road (Unilateral). \$1.9M.
2. Louisville Air Base Access Control Point (Unilateral). \$2.0M
3. Contingency Response Group (Unilateral). \$8.9M.
4. Joint Forces HQS, Frankfort KY. \$15.0M (Joint with Army National Guard).

COL King and MAJ Barger, Kentucky Army National Guard, presented the top projects from the FY14 Long Range Construction Plan (LRCP).

1. Joint Forces Headquarters (JFHQ) Readiness Center (Joint with Air National Guard). \$15.0M with (up to) \$2.0M in Air Guard share.
2. Burlington Field Maintenance Shop. (Unilateral). \$12.0M
3. Maysville AFRC. (Joint with USAR). \$15.0M.
4. Somerset AFRC. (Joint with USAR). \$15.0M.
5. Wendell H. Ford Regional Training Center (WHFRTC) Regional Training Institute (RTI) Addition and Alteration. (Unilateral). \$12.0M
6. Pikeville AFRC (Offered as Joint with any interested component). \$15.0M
7. Leitchfield Readiness Center Addition/Alteration. (Unilateral). \$2.0M
8. Shelbyville Readiness Center Addition/Alteration. (Unilateral). \$2.0M
9. Brandenburg Readiness Center Addition/Alteration. (Unilateral). \$2.0M


E. OTHER BUSINESS


